Notwithstanding any other provisions of this Code, when the Village conducts inspections of a tenant's apartment in a multi-family dwelling or any other dwelling that is not owner occupied, the Village must obtain the consent of such tenant or non-owner occupant to conduct the inspection. If such tenant refuses consent, the Village may attempt to obtain a warrant pursuant to Section 8-7-5D and Section 8-7-9.
