Mayor Henyard – For the record residents the tax levy has not been increased. It's been the same it's at 0, no one has increased your property taxes, that is for the record.

Trustee House – I do understand the 0% but I was also looking at the recommendation and the Ordinance from last year compared to this year and the numbers from my reading do not indicate a 0% increase. Additionally, the recommendation from Kasperek shows a net 2.77% increase. If it is at 0% I would ask that someone provide clarity on the difference between last years to this year.

Mayor Henyard - Just so you know how this goes, we have Kasperek that's our accounting. What they do is, is they go and find out where we're struggling at in the Village of Dolton and they give a synopsis to the board of Trustees and myself. They tell us where we're strong at where we're weak at, where we need to increase, where we need to decrease. So just like the last meeting we have this board of Trustees a breakdown of what the accountant recommendations were but it's up to us as a body to choose whether we want to increase or decrease anything in the village of Dolton.

Trustee House – My position is that I am seeking a net 0% tax increase. I will vote in favor of that. If there's anything that represents a net increase, I'm not in favor of that.

Keith Freeman- Just for the record, again, there is a net 0 and if you look a section 2 of the tax levy it says, That the County Clerk is hereby directed to add to the amount levied above a sum equal to 0% of said amount to cover loss in collecting the tax for all funds which 0% shall remain in effect for all future tax levy ordinances unless otherwise provided therein. I don't want to try to do semantics 0% is 0%.

Mayor Henyard – For the record, you guys will be voting on a 0% increase as it relates to anything dealing with the tax levy.
