8. COMMITTEE REPORTS

Police – Trustee Holmes – I'll be meeting with the owner of the laundry mat on Sibley Wednesday or Thursday this week. We're going to address his security cameras.

Melanie Fitness Center – Trustee Brown- As of today's date we are still in the negative for \$62,000. It looks like that will soon be the Police department.

Public Works – Trustee Steave – I would like to ask either Administration or Stacey Carrel what's the number of employees we have? I know we were budgeted for 25/26, we are over that now. Are there any new hires going on now?

Mayor Henyard – That's information you can receive from either Tanjinque or Janice or the Village Administrator.

Trustee Steave - The reality is, I went to Public Works today and anyone in this administration is petrified to talk to any Trustee out of fear for their job. So I can never really get any straight answers so I figured I ask publicly to see if I can get a straight answer. So I'll do it again, I'll e-mail the Public Works Superintendent, Village Administrator and HR. If they respond I'll come back and say I've gotten a response, if they don't respond I'll come back and say that as well.

Fire – Trustee Belcher – No report

Youth – Trustee Norwood – I would like to thank the staff at Thornridge high school for allowing Trustee Brown and I to speak to the seniors on career day last week. We had an entrepreneur join us to discuss careers and job interviewing process. I would like to thank Lincoln elementary school for allowing us to read books and distribute books for the children. Also thank you to Wild Formula Network that made this possible. Sunday, December 18, 2022 we will be having a toy give away, 2pm – 4pm at Dolton park District. Lastly, we are having our second annual family skate night. I will be sending the details later this week via our Trustee's communications.

Finance – Trustee House – This fiscal year which represents the months of May 2022 – October 2022. The Village operating fund does have an operating deficit of \$3.4 million. A year ago in October we did start receiving property taxes, this year we have not. A year ago we received about \$2 million in property taxes more than what we received this year. My estimation is that \$2 million of that debt could be attributed to property taxes. The other \$1.4 million, at this moment, I'm not able to provide an explanation so I'm going to ask that somebody in this administration be able to do so when they're able to make that presentation. The other component, the information provided, in which myself and the other board members just received regarding the corporate tax levy was presented to the board members within the past 15 minutes. With the recommendation of a tax increase of net tax increase of 2.77%. With that being presented to the board and other concerns being raised, I want to make sure that the residents are aware and I would ask for a feedback prior to us/board members making a vote on that.

Mayor Henyard – For the record anything that you guys have before you is from prior administration. Anything as it relates to increase is from prior administration such as the previous Mayor. We all have gotten the information as it relates to what they want us to do. So, I just advise everybody moving forward to read your e-mails go back into your data logs and you will see that you had this information for literally the last 4 years because we get on this board you automatically know the financial status of this village. Which I have been trying to fix with my administration. So I just want to put that on the record because people can easily get up here reciting numbers, tell you this, tell you that but they never give you facts or concrete proof or put it on paper to show you exactly what's what. Next year I will be hosting something you show you exactly the financials. For those of you who don't

understand we will break it down so that you understand step by step where we are and where were going but I need the board to support the movement so we all can be on one accord and our village will always be in the positive.

Tanjnique Miller – Just one point. Overall taxes revenue is 2.1 million below prior year so in fiscal year 22 at this time we have \$5.6 million collected, compared to 3.54 million in fiscal year 23. So, you said that there was a variance of 3.4 million so that breaks down the general operation of and city of Chicago revenues have decreased a combined 2 million with an additional 2.3 million decrease in debt service revenues so that's what its related to. Does that help you?

Trustee House – I'll reach out to you, I did not follow that completely but I appreciate the response.

I noticed that there are \$54,456.07 worth of credit card transactions that do not have a receipt. That has been provided for us to review for fiscal year 2023 which is the months of May- September 2022. Additionally, there are 64,899.66 worth of credit card transactions that did not have a receipt for fiscal year 2022. This according to our CPA who submitted an e-mail requesting that information.

All bills with appropriate receipts be paid with an email consent if receipts are produced.

Mayor Henyard – The attorney advised me to ask you if they ask you if they can be approved once you make sure you have what you need.

Trustee House- If they are provided then I will consent to an email consensus.

Trustee Belcher – This information that Trustee House is speaking of, the first e-mail went out in September the second one went out November 23, so it's been well over 4 months that these receipts have not been produced so for us to say we're going to approve it and he's been requesting it for the last four months it seems everything else should have receipts, why is he waiting four months?
