# Village of Dolton Regular Meeting Board of Trustees Virtual Meeting Via Zoom - Livestream on YouTube Monday, February 1, 2021

CALL TO ORDER

In the absence of Mayor Riley H. Rogers, Village Clerk Mary Kay Duggan called the Regular Meeting of the Board of Trustees to order at 6:39 p.m.

**ROLL CALL** 

The following trustees were present: Tammie Brown, Deborah Denton, Tiffany Henyard, Andrew Holmes, Jason House, and Edward Steave.

Also present: Village Administrator Elizabeth Scott, Cris Miroballi of John Kasperek Co., and department heads. Village Engineer Ron Smith was absent. Village Attorney John Murphey joined the meeting at 6:50 pm.

A quorum was present.

Trustee Steave spoke on behalf of Mayor Rogers and family, reporting that Mayor Rogers is ill and is expected to recover.

The village asked for a motion to appoint a Mayor Pro Tem to chair the meeting.

#### **GENERAL ANNOUNCEMENTS**

Trustee Holmes reminded residents to look out for neighbors with all of the snow. He asked who cleaned the village hall after the recent covid-19 testing. He said that residents and employees should be told.

Village Administrator Elizabeth Scott responded that the village hall was chemically cleaned. Village Clerk Mary Kay Duggan and Communications Director Giavonni Nickson both confirmed that Saturday's testing took place outside in the driveway.

Trustee Henyard reported current Covid-19 statistics. She announced that there is rapid testing at Abundant Living Church.

Administrator Scott announced that she has received a second response to the Request for Proposals for a forensic audit.

Cris Miroballi reported that the county's extension of the deadline to pay property taxes could affect cash flow. The village is okay with vendors and payroll for the coming month.

Trustee House and Trustee Holmes said that residents had reported difficulty accessing the live stream chat box at the recent finance committee meeting. Ms. Nickson said that there was a 10-minute delay in populating chat box at that meeting. She has confirmed with residents that they have access this evening.

Village Engineer Ron Smith submitted his written report. Trustee Holmes said that he wants a meeting with the engineer and board members to discuss infrastructure. Trustee Steave commented that such a meeting may violate the Open Meetings Act. Trustee House suggested a public works committee meeting.

# **COMMITTEE REPORTS**

### Trustee

#### Finance

Trustee House announced that the finance committee met on January 28<sup>th</sup>. The committee is mindful of the village's financials with possible delay of the property tax revenue. With the \$700,000 plus CARES funds, there is only a \$300,000 surplus.

#### Housing

Trustee Tammie Brown reported that there were 20 "as-is" inspections in January with \$20,000 in fees collected. Total revenue for January was \$79,300.00.

## Police and Fire

Trustee Holmes read aloud the Dolton Police Department report for January. The department responded to 1,648 calls for service. Trustee Holmes said he is investigating a possible "chop shop" in the village. The Dolton Fire Department reported 376 total incidents.

### **Publiic Works**

Supt. Matt Stacey reported that two shifts are on snow removal beginning 4 pm. on Saturday through 8 pm. on Sunday.

# Melanie Fitness Center

The fitness center is listed with a realtor for sale. The DeTox Café remains open.
