# A veto message related to December 14, 2022 Special meeting was read into record by Mayor Henyard (message attached).

Clerk Key – For the record, the Deputy Clerk and I attended training for the Clerk's office to make this office function better and more efficiently. There are funds in the budget to cover every training that we attend. Every neighboring municipality, who are the same distance from downtown attend these conferences and get hotel accommodations for their entire team. It is a state conference that everyone in the State of Illinois who is an elected official attends and they all stay overnight. Why is Dolton being penalized when prior administration's stayed downtown for years? It's been a common practice that every municipality in the State of Illinois attend these conferences to update themselves on the state laws as they change. If no one attends, how do we stay current? My Deputy Clerk is new; I'm learning new Clerk functions. We've attended conferences all over, Bloomington, Elk Grove, we've attended conferences all over the State of Illinois. Why aren't our bills being paid? Numerous bills are being paid for your group of people to travel all over the country. But yet, she and I to educate and to improve our office attend trainings and month after month our invoices are not being processed. Tell me what's wrong with bringing new ideas, new laws, making sure this Village functions in the capacity that it should. Are you telling me that I shouldn't do that? And, if you're saying that, then I will not go but as long as the laws continue to change in the State of Illinois someone here needs to attend these trainings so that we can stay abreast of the changes in the state of Illinois. I'm not doing this because I'm going on vacation. I'm doing this because I want to improve the functions of the Clerk's office and the Village. But yet, that is being blocked. My Deputy is barely being paid a salary and you're going to block her invoices as well? She's barely being paid but when she attends conferences you're blocking her invoices. What expense account? She doesn't have an expense account. She does an excellent job in the Clerk's office, you want to know why? Because she attends these conferences and trainings. She brings things back to this village and does her job very well. You get results out of our office other than FOIA's because we rely on other departments but anything else if you call our office you're going to get results so why are you blocking that?
