Trustee Brown – There continue to be a deficit with Melanie Fitness Center. Current deficit is \$31,477.00. Need to come up with plan for the facility. Floyd Mayweather is putting up gyms everywhere, will share details at a later date. Mayor Henyard mention she has been in communication with Commissioners at Dolton Park District to take over the facility.
