- 4. Discussion and Possible Action Regarding Approval of Ordinance No. 21-009 The hiring of Legislative Counsel Trustee House
 - Discussion Trustee Belcher stated the trustees are acting on behalf of the residents. Trustee House stated they are requesting approval to retain Atty. Michael McGrath as legislative counsel for the board of trustees. Board meetings have not been conducted properly and they tried the assistance of a mediator but the Mayor did not show up. Funds are available in the budget for legal counsel. The retainer agreement is for \$175 per hr. other attorneys are getting \$200 per hr. Motion by Trustee Norwood second by Trustee Belcher.
