

**ORDINANCE NO. 18-019**

**AN ORDINANCE LEVYING TAXES FOR GENERAL AND CORPORATE PURPOSES FOR THE 2018 TAX YEAR BEGINNING MAY 1, 2018, AND ENDING APRIL 30, 2019, FOR THE VILLAGE OF DOLTON, COOK COUNTY, ILLINOIS**

BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Dolton, Cook County, Illinois, as follows:

**Section 1**

That the amount of \$7,865,190 is hereby levied upon all taxable property within the corporate limits of the Village of Dolton, Cook County, Illinois, for the 2018 tax year beginning May 1, 2018, and ending April 30, 2019, for the following corporate purposes, which sums are set forth under the column entitled, "Amount to be Raised by Taxation":

**Section 2**

That the County Clerk is hereby directed to add to the amount levied above a sum equal to 14% of said amount to cover loss in collecting the tax which 14% shall remain in effect for all future tax levy ordinances unless otherwise provided therein.

**Section 3**

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

**Section 4**

All statutes of the State of Illinois or any parts thereof which are in conflict with the provisions of this ordinance are hereby superseded by this ordinance enacted under the home rule power of the Village of Dolton.

**Section 5**

This ordinance shall be immediately in full force and effect after passage and approval.
