MAYOR HENYARD: Yes, it definitely will, added more police officers.

RESIDENT QUESTION: Out of respect to the Fire Dept., why wasn't the meeting postponed until after His funeral?

MAYOR HENYARD: Didn't know the funeral would be scheduled today. As you know we have to post This 10 days in advance legally. There are people on behalf of the Mayor There to speak.

RESIDENT QUESTION: What date was this notice posted for general public?  
CLERK: July 21, 2021.

RESIDENT QUESTION: Are we going to get clear answers about this budget? Why are salaries combined line items example: police chief say \$270,000, village administrator - \$200,000.  
CRIS MIRCOBELLI; Notes in the descriptions: \$270,000 for police chief and (2) deputy chief. \$200,000 for village administrator – (2) executive assistants for Mayor and Village administrator. It has a detail breakdown for each line item.

ATTORNEY VASELLI: I want to remind everyone that this meeting is virtual due to the pandemic. When We adjourn we need a roll call vote on the adjournment rather than by consensus To vote for motion to adjourn due to virtual meeting because of pandemic.

RESIDENT QUESTION: Repeat budget items.  
CRIS: \$270,000 is for (1) police chief (2) deputy police chiefs. \$200,000 is for (1) village Administrator (2) executive administrative assistants for Mayor & village Administrator.

RESIDENT QUESTION: Budget I received doesn't have individual salaries. Why is that? How much does Deputy chief makes?  
CRIS: Police Chief salary is \$100,000 (1) deputy chief salary \$80,000 and other is \$86,569. The reason for two deputy chiefs is one is on medical leave so until this Is resolved, two deputy chiefs are on staff.
