The Rental Registration and Inspection Fees and the Rental Registration Renewal Period have changed. See tables below:

Renewal Period

(Effective Date of Ordinance October 4, 2021)

Registrants	Fee Paid	Renewal Fee Due Date
Paid for Current Year	As of the Effective Date of the Ordinance (October 4, 2021)	No Later Than Ten (10) Days After the Twelve (12) Months From the Date Paid in 2021
Not Paid for Current Year	Current Year Fee, Plus Non-Payment Penalty Due, Thirty (30) Days After the Effective Date of the Ordinance (October 4, 2021)	Subsequent Years Rental Fees Due, No Later Than Ten (10) Days After the Twelve (12) Months From October 4 th of the preceding years.
New Registrants	After the Effective Date of the Ordinance (October 4, 2021)	Renewal Due, No Later Than Ten (10) Days After the Twelve (12) Months From the Date of Payment for the Initial Registration

Penalties

- Renewal Registration payment will double by 100% if not paid ten (10) days after the renewal registration payment is due.
- Unpaid Renewal Registrations may be placed with a collection agency and additional penalties will apply.
