MINUTES

- CALL TO ORDER/ROLL CALL at 6:35 pm by Mayor Pro Tem House. Present (5) Trustees Norwood, S. Brown, T. Brown, Belcher & Mayor Pro Tem House, Deputy Clerk Aris Montgomery. Absent (1) Mayor Henyard, Clerk Key & Trustee Holmes. A quorum was established.

- 5. GENERAL ANNOUNCEMENTS –

Trustee Belcher – Please understand what a trustee does. The trustees are the legislative body. We would never take anyone's escrow off of the warrant list. Escrow funds have not been removed from the warrant list, we remove unapproved spending. We do not remove things that are in the benefit of the community. Despite all of the chaos, we have come together as a community. I'm going to try to host Pray for Dolton next month October. This community needs healing.

Trustee Norwood – Happy to have the support of the residents. We have a few partnerships that helps the board. A special thank you to the Dolton Park District. Every year they help with the Youth Empowerment Program and partner with Dolton to provide the youth with jobs. I would also like to thank Chicago Sky Game and the residents who attended the game.

Trustee S. Brown – I'm here because your concerns are my priority. I am here for all of the residents. Trustee T. Brown – I would like to thank the Dolton Fire Department who continuously worked without a contract for years. This Saturday, September 14, 2024 will have Tea with the Trustees. Mayor Pro Tem House – I received several calls regarding the unofficial board meeting. Any procedures and attempted appointments are not valid. We are here to defend the residents of Dolton. Moving forward we will not be recognizing any comments made by the Mayor. We have real issues that we're here to address. We have to make sure that we stand together, stand strong and stabilize this community.

Attorney McGrath – The Illinois Attorney General issued a binding opinion in response to complaints made by three (3) residents. September 3, 2024, the Attorney General's office concluded that the village violated the Open Meeting Act by failing to make meetings convenient and open to the public. You have to have a quorum in order to have a legal meeting. No action taken at that meeting will be up held. Any

appointments made has to be done in a board meeting where the trustees are present and has the chance to give the advice and consent.

Mayor Pro Tem House – There was news on the Comptroller's office freezing some funding for the Village of Dolton. Working through the Village Administrator and the Finance Director, we've been in constant contact with their office. They've communicated that as long as we have a plan in place by September 15, we can begin the process of getting our funding restored.

We are in the process of doing a reconciliation for the previous fiscal year. Our next fiscal year budget is past due. We expect to have that within a month's timeframe.

Audits have not been completed since this administration has taken over. The auditor that we have on record has refused to issue an opinion because of the many reports, subpoenas and allegations of fraud. We've reached out to ten (10) firms who share the same concerns. As of today, we have two (2) firms that are interested in picking up the mantle and moving things forward for FY 2022 and FY 2023 to get us back on track.

Lastly, the board voted for an approval of all of the checks that were deemed appropriate. When those checks were presented for the Mayor to sign, she declined. Fortunately, we have an ordinance in place that states when the Mayor refuses to do her job the Mayor Pro Tem is in power to do that. Thank you to the board for having foresight for a situation like this. With that, Clerk Key and I signed checks to ensure that vital services continued. The Mayor's office then contacted our bank claiming false signatures on the bank account. The bank issued a 60-day notice stating that our accounts would be closed within that timeframe. Despite allegations there has been no binding opinions against the board and we will continue to follow the advice and consent of the attorneys. We expect to have a new banking relationship within the next 30 days.

Trustee Belcher – Last month we paid KNM Ventures \$35,000 because of a storm that we needed them to come out for. We were very grateful for their service. As Trustee Norwood and I went through their invoices and visited homes were service was provided, there are still tree trumps, branches, etc. that haven't been removed. On the invoice's it stated that it would be removed. Why would we pay them more money if they haven't completed what we've already approved?

My other concern is R.E. Walsh & Associates which is a law firm that stated that they did the investigation for Las Vegas. The board still has not received a report of what was done.

My last concern, Senior Trustee House requested a draft copy of the budget about a month and a half ago. We pay our accounting firm between \$40-60,000 a month. Whatever we request we should receive. We shouldn't have to have outside entity's come in and subpoena information when all of those records are in the hands of our accounting firm. I want it on record that this is our money and they should be providing the necessary information we need to move this village forward.

Trustee Norwood – We've been fighting hard for transparency. We will continue to remove things that are not in the best interest of the community and hold this administration accountable.

Trustee T. Brown – In our budget there is funding for us to go to IML and to stop the training but the Mayor has stopped that. If we didn't spend the \$10,000 that was set aside for that, where did the money go?

Attorney McGrath – It's important to go back to Ordinance 24-010. It is an ordinance establishing a travel policy which the village never had before. This puts a halt on extreme travel expenditures and entertainment. This ordinance takes it a step further by putting an actual freeze on travel expenses with an exception to the IML.

Attorney McGrath – The law is very clear regarding appointments. The Mayor can remove or add an appointed position or official with the advice and consent of the board. It has to be done in writing and there are time constraints and it has to be done in a meeting. If the Mayor fails to follows these steps, then it's not a proper removal. Then the corporate authority can move to restore that appointed official with a 2/3 vote. There is a number of grounds on why his removal has no merit. I asked for this to be added to the agenda in case it was challenged in court.

Trustee S. Brown – It's kind of confusing right now. I don't understand how he can carry out the job of a Village Administrator if he's working from home. I'm not comfortable with that.
